To whom it may concern,

There is a bill working its way through the Minnesota legislature (Senate File 3480 and House File 4304). The bill appears to have significant ramifications that change how tracts of land within the White Earth State Forest will be managed in the future.

The Chairman of the White Earth government has given full-throated support of the bill as it stands, and that is worrisome.

Our homes on Bad Medicine Lake are located on reservation land. Should this bill become law, it is possible that we will lose access to our homes in which we are heavily invested. That is just one issue and it will affect many residents in the impacted area.

Northern Minnesota offers many opportunities to enjoy the outdoors. The loss of access to forest land, lakes and trails will close the door on hunting, fishing, snowmobiling, four-wheeling, and other recreational activities. Business owners, large and small, fear the loss of tourism and its economic impact on their livelihood.

Governor Walz promised One Minnesota and transparency in government. This bill pits one people against another, and the lack of public announcements and scheduled hearings makes it appear the authors are sneaking it through to passage.

Transfer of public lands must include the protection of the rights of all. One injustice on top of another injustice does not equal justice. This bill in its present form has no such protections. Passage of it will set back the working and neighborly relationships that White Earth members and non-members have held close for decades.

Our Founders formed our magnificent Democracy guided in part by the democratic processes of the Tribes in the original colonies. We should apply those principles and proceed to address this in a deliberate, thoughtful, researched approach that includes all of us. For that to happen, this bill needs to be changed.
